

## Overview of planning until end of 2020



### **Overview of planning until end of 2020**

- Continuation with the work of the new Expert Groups
- Continuation of the work with the standardization bodies (e.g. CENELEC, IEC, IECRE)
- Development and publication of the second edition of the monitoring report (by end of 2020) + a revised monitoring excel file to be launched
  - Currently the data collection is being finalized
- Submission of a first set of updated IGDs for public consultation. The consultation will be launched end of November 2020 and will last until mid-January 2021.
  - -> Updates will also reflect discussions and outcomes at GC ESC level
  - -> No new IGDs will be launched this year, however ENTSO-E takes note of the relevant discussions and outcomes at EG level
  - -> As in the past, ENTSO-E will plan revisions or new IGDs beyond the 2-year revision cycle as defined in the CNCs
- ENTSO-E will plan a webinar with the Technical Group Compliance Monitoring and interested GC ESC members to discuss the draft Compliance verification and IGD on Compliance Testing.
