
#### Action points from the EBSG meeting


A written response to all the questions raised by EURELECTRIC was sent.

# **TP Graphical User Interface (GUI) Update**

#### **Stream I - TP GUI Implementation**

• As part the TP's new GUI implementation scope, Phase III activities have been kicked off in the second quarter of 2022. Phase III has been planned to be implemented in 3 streams. Currently, the Stream I is in progress.

The Day-ahead Prices (TR art.12.1. D) data item, was successfully launched on the new TP GUI in full scope with graphical, tabular and map views. Click <a href="here">here</a>.

- Streams II and III have target go live dates in April and August 2023
