
TYNDP 2020 - Practical guide for submitting a project in the online platform

Document Use

This document is intended to provide simple step-by-step instructions on how to submit project in the TYNDP 2020 project collection platform.

1. ACCESS TO THE TYNDP ONLINE PLATFORM

The TYNDP platform is accessible at this link: <https://tyndp2020-project-platform.azurewebsites.net/>

If you have not been a project promoter in any of the previous TYNDPs, you will need to contact ENTSO-E in order to get credentials to access the online platform. Once created, your credentials will be sent to you by email and you will be able to submit a project.

Promoters of projects who were in previous TYNDP(s) should already have access to the platform.

Your login should have this format: entsoe\[first letter of your first name][last name]

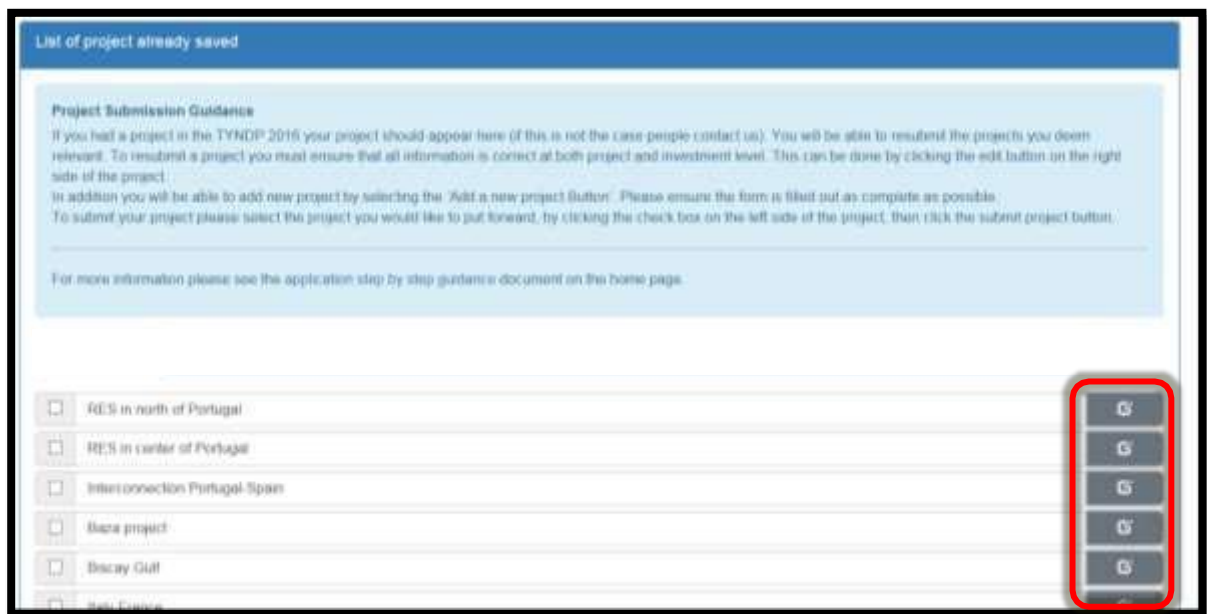

2. PROJECT SELECTION

Choose which type of project you would like to submit from the options at the bottom of the home page.



2.1. EDITING AN EXISTING PROJECT



If you had a project in TYNDP 2018, the project will automatically show up in your section. You will be able to modify your existing projects by clicking on edit button on the right hand side of the screen. Please ensure all data is up to date.

2.2. CREATING A NEW PROJECT



To add a new project, scroll to the bottom of the page and select a new project. When you select a new project, you will automatically be given a project number. Similarly, when you select a new investment you will automatically be given a new investment number.

The process to fill out the project is relatively self-explanatory, for more information please refer to the Guidance or contact lea.dehaudt@entsoe.eu.

3. FILLING IN ADMINISTRATIVE AND TECHNICAL DATA

After clicking on editing a project or creating a new project, you will see a submission form. It will allow you to submit the administrative and technical information and documentation required in the Guidance.

3.1. SUBMISSION FORM FOR TRANSMISSION PROJECTS

The table below replicates the online submission form that transmission project promoters will be required to fill in when applying to the TYNDP2020.

5. Submitting a Future project in the 2nd submission window

To submit a Future project addressing system needs, the submission forms are identical to those detailed below, with a few exceptions:

- Future projects do not need to prove fulfilment of the additional administrative criteria f to l and cannot feature in a NDP or have PCI status. Therefore the following fields are not available and should not be filled in.
